# We never forget...

On February 7, 2018, the Virginia State Police aviation hanger in Chesterfield County was renamed in honor of Lieutenant-Pilot H. Jay Cullen.

The helipad at the State Police Administrative Headquarters in North Chesterfield was renamed in honor of Trooper-Pilot Berke M. M. Bates on April 18, 2018. In November, the bridge on Route 612 (Airport Road) over Interstate 64 in New Kent County was dedicated as the "Trooper Pilot Berke Bates Memorial Bridge."



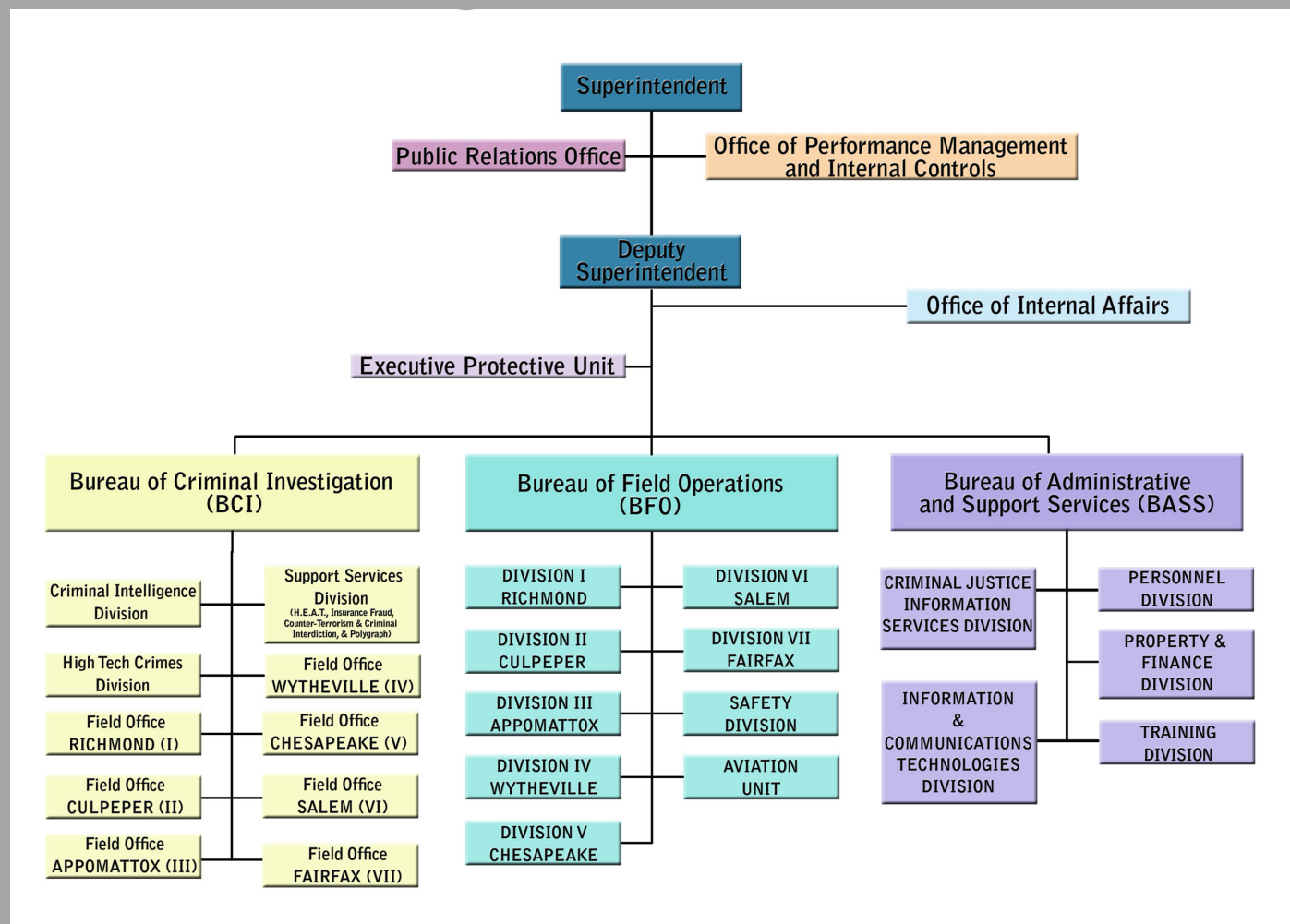
Lt. Cullen and Trooper-Pilot Bates were killed in the line of duty on August 12, 2017, when their Bell 407 helicopter crashed into a wooded area of Albemarle county.

The life and service of Special Agent Michael T. Walter was honored October 26, 2018, when a portion of Route 13 in Powhatan County was dedicated as the "Trooper Michael Walter Memorial Highway."

On May 26, 2017, Special Agent Michael T. Walter had walked up to a vehicle in the City of Richmond and was shot by the vehicle's passenger. Special Agent Walter succumbed to his injuries the following morning.

# SUPERINTENDENT'S OFFICE

## EXECUTIVE PROTECTIVE UNIT (EPU)

The plainclothes troopers assigned to the Executive Protective Unit (EPU) provide 24-hour security for Governor Ralph Northam and his family. EPU coordinates the Governor's schedule, secures routes for his upcoming appearances and events and works with local, federal and law enforcement agencies from other states when traveling to ensure maximum security and effectiveness of the detail.

## PUBLIC RELATIONS OFFICE (PRO)

The Public Relations Office is responsible for the development and implementation of comprehensive, proactive public and media relations information and outreach regarding traffic safety, crime prevention and criminal investigations. The PRO expanded VSP's social media footprint by launching an agency Instagram page in an effort to reach new audiences with key recruitment messaging. The civilian PRO staff works closely with the field Public Information Officer (PIO) sergeants and produced 29 statewide press releases in 2018 and fulfilled more than 1,000 media inquiries. The PRO also provides assistance to local sheriffs and police departments with major incidents, as well as the offices of the Governor and the Secretary of Public Safety and Homeland Security.





# SUPERINTENDENT'S OFFICE

## YOUTH OF VIRGINIA SPEAK OUT ABOUT TRAFFIC SAFETY (YOVASO)

A statewide, peer-to-peer advocacy program that engages, educates and empowers Virginia's youth to influence a safe driving culture through leadership development and innovative outreach programs. Its vision is to establish generations of safe teen drivers in Virginia. In 2014, VSP absorbed the federally-funded grant program, which was established in 2001 by the Blue Ridge Transportation Safety Board and the Virginia DMV Highway Safety Office.



In 2018, seven new YOVASO programs were established at schools and youth groups in the counties of Chesterfield, Stafford, Henrico, Spotsylvania and Smyth and in the cities of Staunton and Norfolk. During 2018, the program sponsored four traffic safety campaigns for schools statewide, reaching 64,918 students with educational information on driver and passenger safety. In partnership with VSP, YOVASO also provided the interactive Distracted/Impaired Driving simulators and the ScanEd Physics of a Crash program to 55 schools, reaching 22,484 students. The program also hosted its annual Summer Leadership Retreat in June for 151 Virginia high schools students and school sponsors. Over 162,600 educational materials were distributed.

YOVASO, with a staff of 3 full-time civilians and part-time youth advisors, currently has 106 member schools and youth organizations. In 2018, close to 1,500 trained YOVASO student leaders actively planned and implemented peer-to-peer traffic safety initiatives for their schools and communities.





# SUPERINTENDENT'S OFFICE

## OFFICE OF PERFORMANCE MANAGEMENT & INTERNAL CONTROLS (OPMIC)

OPMIC tracks, monitors and guides the Department's progress towards achieving and sustaining agency and state government objectives and strategies.

**Information Security Section:** Ensures data security for all types of sensitive information within the Department's purview. The safeguarding of this data within the Department's operational and highly mobile environment is its primary goal.

**Internal Audit Section:** Performs audits and reviews of Department operations for the purpose of monitoring the agency's performance. One special project and three audits were completed in 2018. This section works to maximize the efficiency and effectiveness of Department operations and strengthen internal controls. This section routinely reviews financial data and reporting mechanisms, regulation and policy compliance, asset safeguards, loss detection and prevention, and technology data system security.

**Staff Inspection Section:** Conducts inspections of all VSP organizational components, ensuring compliance with accreditation standards, regulatory requirements and Department policies and procedures. Six staff inspections were conducted in 2018 for the Bureau of Criminal Investigation (BCI) and Bureau of Field Operations (BFO) including the Fairfax, Wytheville, Culpepper, Criminal Justice Information Services Divisions and the Counter-Terrorism and Criminal Interdiction / Diversion section. The Staff Inspection Section also manages all agency records retention and destruction within and ensures continuous agency-wide compliance with the applicable standards necessary to remain nationally accredited by the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA).

# SUPERINTENDENT'S OFFICE

**Strategic Development Section:** Supports Department divisions and units through equipment studies, program development, research projects, technology evaluations, staffing formula updates, legislative studies and grant management. In 2018, this section administered 45 grant projects worth approximately \$25 million in support of essential Department projects and programs. The section also responded to 207 requests for information from criminal justice agencies and academic research centers nationwide.

## OFFICE OF INTERNAL AFFAIRS (IA)

Initiates and conducts administrative investigations concerning allegations of misconduct on the part of VSP personnel. The office also investigates complaint referrals reported through the State Employee Fraud, Waste and Abuse Hotline. In 2018.

## BUREAU OF ADMINISTRATIVE & SUPPORT SERVICES (BASS)

Provides vital professional support and technical expertise to not only VSP, but also to local, state and federal law enforcement agencies, the state judicial system and the general public. Its role is essential to the successful continuity of a multitude of services throughout its field divisions and offices.

## INFORMATION & COMMUNICATIONS TECHNOLOGIES DIVISION (ICTD)

Manages the symbiotic relationship between the ever-evolving environments of the Department's unique and diversified digital, computer and communications technologies. The ICTD, which is divided into a Communications Section and Information Technologies Section, provides the Department with a global view and unified management of existing and future IT and communications projects.

### COMMUNICATIONS SECTION

**Statewide Agencies Radio System (STARS):** Is composed of VSP and 22 state agencies. The system utilizes P25 standardized digital trunked technology in the VHF 150 MHz band which provides a multi-channel trunked digital voice and data wireless communications capability specifically designed to meet APCO Project 25 public safety requirements. STARS completed the migration of the 700 MHz radio frequency utilization to clear Band 14 for the First Responder Network Authority (FirstNet) operation in Virginia and surrounding states to establish, operate and maintain an interoperable public safety broadband network. To accomplish this project, all 700 MHz radios, their templates and code plugs were reconfigured as part of the Phase 4 project.

The 157 STARS communications sites include:

- 2 legacy sites
- 17 microwave-only sites
- 23 dispatch centers
- 67 contain STARS land-mobile radios
- 48 VSP area offices





# INFORMATION & COMMUNICATIONS TECHNOLOGIES DIVISION (ICTD)

## COMMUNICATIONS SECTION

**Commonwealth Link to Interoperable Communications (COMLINC):** Provides design, engineering, maintenance and tech support for the 155 COMLINC sites statewide. In 2018, COMLINC coordinated communications plans and operations associated with Monument Rally III in Richmond, Pipeline Hearing in Norfolk, Colonial Beach Bike Rally, Unite the Right Rally in Charlottesville, etc. as well as FirstNet testing at the State Fair of Virginia.

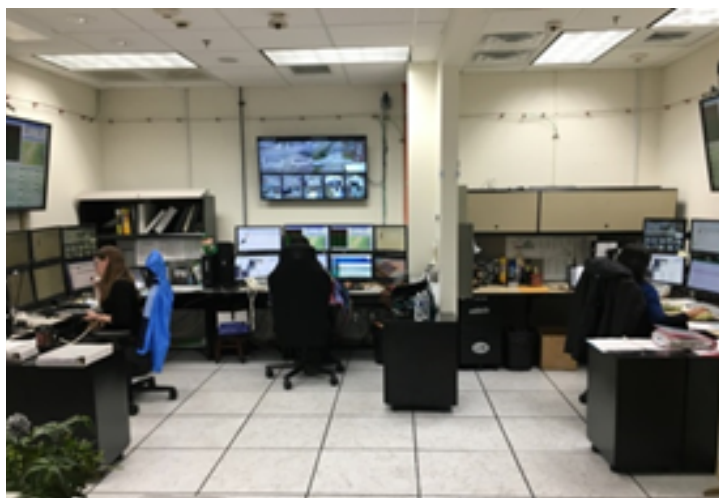
**Computer-Aided Dispatch (CAD):** Allows for rapid entry and retrieval of data-related officer activity and calls for service. CAD supports over 70 dispatch workstations between VSP's seven division Dispatch Centers, as well 100 remote-access users and command post/remote location dispatching terminals used during significant events and critical incidents.. In 2018, more than 1.9-million CAD events were generated and recorded by VSP personnel.

- **CAD Management Information System (MIS):** Central repository database for all seven field division CAD systems. It currently holds 20-million records and enables VSP instant access to calls for service, unit activities, call trends, manpower utilization, response times and disaster-related incidents.



**Mobile Server System (MSS):** Supports 2,500 mobile data terminal (MDT) users and mobile CAD software users from VSP, other state agencies and local law enforcement. MSS interfaces between the MDTs and CAD ensuring full mobile CAD functionality and access to the Virginia Criminal Information Network (VCIN) and DMV records. It also serves as the central interface between CAD, VDOT and the Virginia Fusion Center.

**Network Operations Center (NOC):** Responsible for monitoring the health of the STARS and VSP Networks in order to ensure continuity of the communications systems throughout the Commonwealth. The NOC consolidated with the VCIN Helpdesk which added the VCIN responsibilities to the existing NOC functions and operations. The duties of the NOC including but not limited to, initiating tickets for landline telephone troubles reported throughout the state, programming new radios into the network and enter information into the appropriate databases, initiating tickets for department and STARS supported state agencies vehicles, monitor various systems and remote sites for alarms, monitors the health of the STARS radio network, reset system passwords for VCIN.

## COMMUNICATIONS SECTION

**Vehicle Fleet Management:** Consists of the Installation Facility and the Fleet Services Garage and supports and equips all VSP fleet vehicles for VSP as well as various vehicles for the STARS supported state agencies. Fleet management was instrumental in the Virginia Tech Transportation Institute (VTTI) visibility lighting study to identify ways to improve emergency lighting and visibility for law enforcement officers, which improves their safety and the safety of citizens on the Commonwealth's roadways. Additionally, they initiated the process to replace existing patrol vehicle push bumpers with a new and improved Westin "Wrap-around" push bumper. This style bumper provides for an enhanced ability to effectively and efficiently move disabled vehicles from the roadway, potentially reducing vehicular damage to both the law enforcement and citizen's vehicles.

Communications Section designs, installs, operates, maintains and supports VSP:

Communications Section is responsible for ensuring all VSP-related communications systems and networks are FCC, FAA and EPA compliant. The section actively participates in the Capital Wireless Interoperability Network (CAPWIN) and SAFECOM.

# INFORMATION & COMMUNICATIONS TECHNOLOGIES DIVISION (ICTD)

## INFORMATION TECHNOLOGY (IT) SECTION

### **Asset and Inventory Management System (AIMS):**

Work initiated in 2016 to migrate the Material Management System into AIMS continued in 2018. AIMS retires VSP's legacy MAPPER applications related to asset management.

**Central Criminal History (CCH):** This application is accessed extensively by the criminal justice community to determine an offender's identification and his/her prior criminal record. This system is the sole repository for Virginia's arrests and court dispositions and is relied upon by the entire criminal justice community (law enforcement, courts, Commonwealth attorneys, jails, etc.) for accurate offender information. The CCH System records are based on fingerprint submissions from law enforcement, which ensure the accuracy of the records. The technology and replacement system for Legacy CCH system was successfully implemented in October 2016. Efforts continue to enhance the new system.

### **Consolidated Applicant Tracking System (CATS):**

The IT Section and VSP Criminal Justice Information Services (CJIS) Division established a team to identify necessary enhancements and corrections within CATS. The team is working towards completing system improvements and E-notary automation.

**Data Warehouse:** Created and established nightly data loads from production transaction systems, as well as published data reports for VSP bureaus and divisions. Work continues to expand the warehouse's physical footprint and to add more transactional data from other production systems.

**eVA Procurement:** Integration of Virginia's electronic procurement system (eVA) and VSP's Accounts Payable and General Ledger began in 2017. Full integration will save the Property and Finance Division significant time and aid VSP with meeting payment obligations in a timely manner.

**Evidence Management System (EMS):** Procured to replace the Department's existing MAPPER legacy application related to evidence collection and record-keeping. System implementation and rollout across the agency began in January of 2018.

### **Firearms Transaction Center (FTC) System:**

Significant enhancements to the system began in 2017 that enabled certain federally-licensed firearms dealers to complete application forms for firearm purchases online. The team continues to work towards system improvements, automation and electronic processing of SP-65 form.

### **Oracle eBusiness Suite for Human Resources (OEBS):**

A new team was formed in partnership with the Personnel Division to implement OEBS with Phase I to be initiated in 2018. Upon completion, OEBS will replace and retire the legacy MAPPER HR system.

### INFORMATION TECHNOLOGY (IT) SECTION

**Incident Based Reporting (IBR):** The IBR replacement project will improve the submission and access of incident and arrest information from local law enforcement agencies. Local agencies throughout Virginia are mandated to report statistical information monthly on incidents and arrests on certain categories of crimes. The department, in turn, provides this data to the National Incident Based Reporting System (NIBRS) operated by the FBI. The legacy system was replaced with a SaaS solution in August of 2018.

**Sex Offender and Crimes Against Minors Registry (SOR):** Project initiated to replace the existing, 18-year-old SOR with a modern, more capable online system. Vendor solicitation and selection should be completed by 2019.

The Information Technology Section is responsible for implementation and maintenance of other mission-critical applications and infrastructure that support local, state and federal law enforcement agencies and the general public:

- Virginia AMBER Alert
- Virginia Senior Alert
- Virginia Blue Alert

## CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

Collects, stores and retrieves critical law enforcement data for use by local, state and federal criminal justice agencies, non-criminal justice government agencies, private employers and firearms dealers operating in compliance with state and federal law and policies.

**Automated Fingerprint Identification System (AFIS):** Searches and stores rolled fingerprints and palm prints from criminal arrests, convicted sex offenders and partial latent fingerprints recovered from crime scenes across the Commonwealth. VSP and 24 other state and local law enforcement agencies have AFIS access through terminals located at the respective agencies. The Integra-ID database receives Live Scan fingerprint transmissions and provides automated interfaces to combined criminal history systems, Consolidated Applicant Tracking System (CATS) and AFIS for the purpose of criminal history record searches or latent fingerprint matches.

**Expungement Section:** Tasked with processing petitions for expungement and court-ordered expungements of criminal history information. In 2018, the section received more than 4,279 petitions and court orders, which represents a 1% increase in comparison to 2017. The section also completes quarterly Interstate Identification Index (III) audits and processing criminal record challenge requests.

## CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

**Central Criminal Records Exchange (CCRE):** Established more than 50 years ago, the CCRE is nationally recognized as a leader in maintaining a comprehensive criminal record database, including the development of state-of-the-art programs to deliver the most complete and accurate criminal records information and automated support programs. CCRE conducts criminal and non-criminal record searches, depending on an agency's, law enforcement officer's or individual's need or as mandated by state law.

# CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

**Firearms Transaction Center (FTC):** The first of its type in the nation when established in 1989, the FTC has been cited as an exemplary program and used as a model for other states. The FTC provides Virginia-based Federal Firearms Licensed (FFL) dealers with instantaneous confirmation of a prospective purchaser's eligibility to purchase a firearm. All appropriate state databases and the National Instant Check System (NICS) are accessed as part of the point-of-sale, criminal history record information check approval process for purchase of all firearms, except antiques and curios. FTC transactions are accomplished through V-Check, an Internet-based instant background check program. In 2018, approximately 95% of all transactions, statewide, were processed through V-Check.

## CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

**Sex Offender and Crimes Against Minors Registry (SOR):** One of the nation's most comprehensive public sex offender registries in the nation, the Virginia SOR is designed to protect the general public, with children in particular, by providing personal descriptive, employment and sentencing information on individuals who have been convicted of certain sex crimes and are currently living/working in the Commonwealth. Access to this information and the SOR website is provided free of charge to the public.

**Sex Offender Investigative Unit (SOIU):** Conducts on-site verifications of all residential and employer addresses of registered, convicted sex offenders. The SOIU, which is composed of troopers and civilian compliance officers, conducts criminal investigations related to offenders who fail to comply with SOR registration requirements. Through the Sex Offender Verification System (SOV), the SOIU works closely with local law enforcement, the U.S. Marshals Service and the Virginia Department of Corrections (VDOC) Probation and Parole.

## CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

**Uniform Crime/Incident Based Reporting (UCR/IBR) Section):** Collects monthly IBR data from over 96% of law enforcement agencies throughout Virginia on Group A and Group B Criminal Offenses, as established by the FBI. Virginia crime data, broken down by offenses and arrests by cities and counties statewide, is published annually in the "Crime In Virginia" report and made available via the VSP website. A monthly file of Virginia's data is also generated and emailed to the National Program for inclusion in the FBI's "Crime in the U.S." report.

**Virginia Criminal Information Network (VCIN)/National Crime Information Center (NCIC):** Serving 667 local, state and federal member agencies, VCIN/NCIC store information relating to wanted persons, missing persons, protective orders and stolen vehicles. Warrants and protective orders issued by Virginia magistrates are automatically entered into VCIN/NCIC via the Supreme Court of Virginia E-Magistrate Interface.

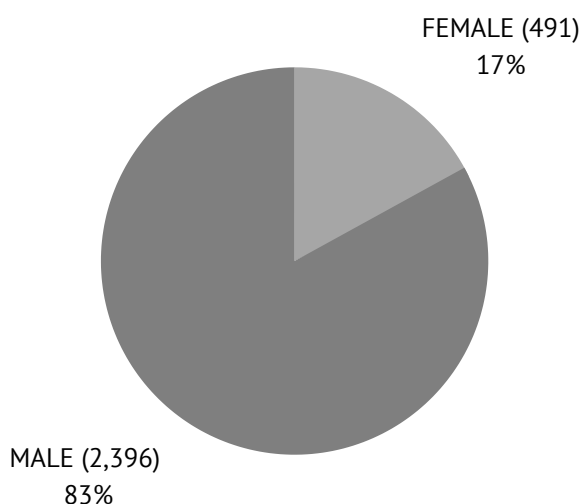

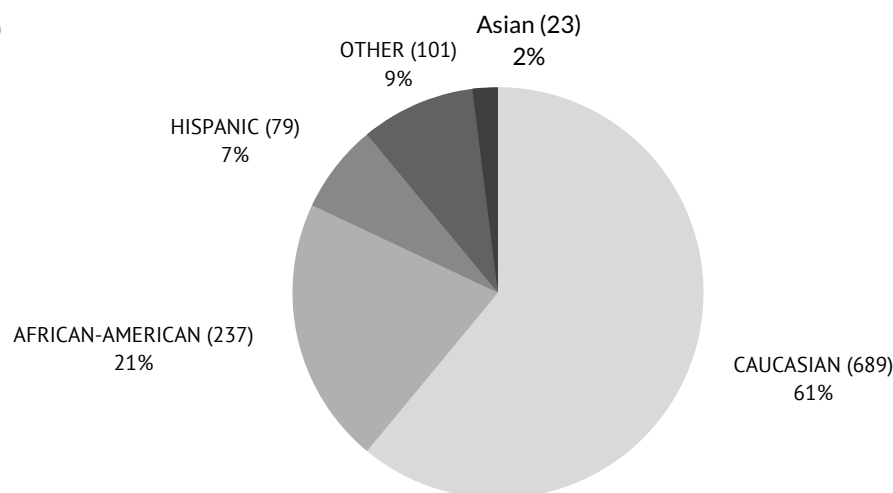
## HUMAN RESOURCES DIVISION

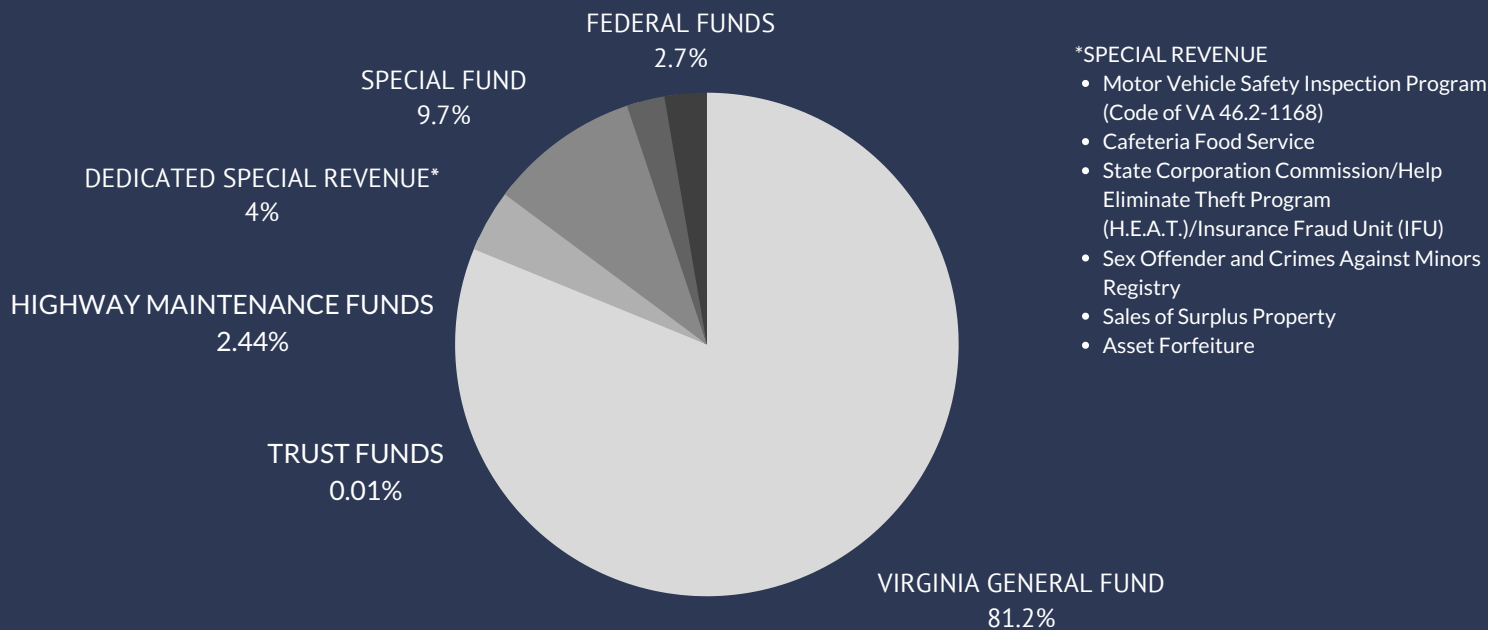

## PROPERTY AND FINANCE DIVISION

All financial reporting is prepared in compliance with applicable state and federal regulations, including but not limited to the Commonwealth Accounting Policies and Procedures (CAPP) Manual and the Financial Reporting Directive by the State Comptroller; and the Federal Office of Management and Budget (OMB) circulars for state and local governments. The Department works with the State Auditor of Accounts (APA) and all federal auditors.

Along with the Office of Performance Management and Internal Controls (OPMIC), the Division continually reviews policies and procedures to ensure agency compliance with the Virginia Department of Accounts's Agency Risk Management and Internal Controls Standards (ARMICS).

During FY2018, the Department:

- Accounts Receivable collected 54.6 million collectively for the Department during fiscal year 2018.
- Maintained a Prompt Payment Act compliance rate of 98.24% on 37,613 total payments.
- Managed asset forfeiture accounting, in accordance with applicable state and federal guidelines and reporting requirements

The Division oversees the property management and maintenance of 130 Department buildings and real estate across the Commonwealth.

In 2018, a new Area 12 Office located in Warrenton, Virginia is currently under construction. Extensive renovations and upgrades to the Area 45 Office in Arlington, Virginia is occurring. A new garage/warehouse storage facility for the STARS program has also started construction. Planning is occurring for a replacement of the existing Division VI Headquarters located in Salem, Virginia.



Virginia Excess Military Property Program aided a total of 155 Virginia law enforcement agencies with procurement acquisitions of surplus military property and equipment via the U.S. Department of Defense.

The 1122 State and Local Law Enforcement Procurement Program allows state and local law enforcement agencies to purchase, at substantial savings, law enforcement equipment suitable for counter-narcotic activities through federal procurement channels. In 2018, the Department purchased \$7.9 million worth of equipment for a net savings of \$731,738 during this fiscal cycle.

## TRAINING DIVISION

---

Recognized nationwide for its exemplary training standards, instructional curriculum, and cadre of skilled, expert, certified instructors.

The Training Division is comprised of two primary facilities, the Academy located in North Chesterfield and the Driver Training Complex (DTC), which includes the Driver Training Unit and Tactical Operations Unit, in Blackstone. The Training Division also maintains a satellite canine training center located at the Abingdon Regional Jail in Washington County.

**Driver Training Unit** - conducts various courses throughout the year in:

- CPR / First Aid /
- Trauma Kit Training
- Pursuit Intervention Technique
- Motorcycle
- Speed Measurement

**Tactical Operations Unit's training includes:**

- Officer Survival
- ALERRT (Advanced Law Enforcement Rapid Response Training)
- Tactical Team /Tactical Field Force
- Sniper Training /Firearms Training

Trooper In-Service for the Department's troopers and commercial motor vehicle enforcement officers was completed over a 28-week period. Each session consisted of 40 hours of instruction and included training in legal issues, cultural diversity, blood borne pathogens, first-aid/CPR, defensive tactics, physical fitness, officer safety, defensive driving, and firearms.

The Training Division also conducted and hosted various other courses throughout the year, which included training such as Advanced Crash Investigation, Crime Prevention, Criminal Intelligence and Analysis, Defensive Tactics, Dispatcher, Driving Under the Influence/ Standardized Field Sobriety Testing, First Line Supervisor Leadership and Professional Development, Police Shooting Investigation Training, etc.

## NEW TROOPERS GRADUATED

On May 11, 2018, the 127th Basic Session graduated 52 new troopers.

The Department's first Advanced Lateral class entered the Academy as the 128th Basic Session and graduated on June 22, 2018. The 39 graduates entered the Academy as certified Virginia police officers with at least three years of law enforcement experience.

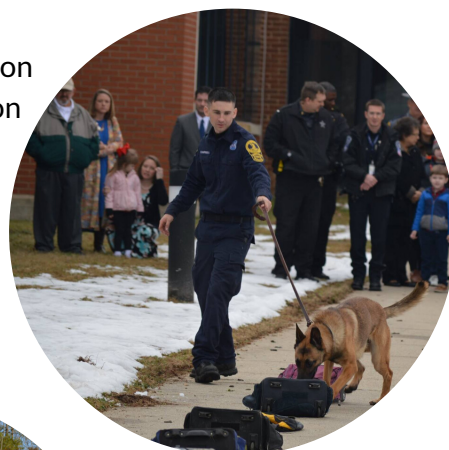
### Youth Cadet Law Enforcement Training Program

Students experience a life similar to a trooper-in-training, which includes daily room inspections, and instruction by troopers, which include topics such as crime scene investigations, officer survival, defensive tactics, firearms, safety, and driver improvement.

### Canine Training

The Canine Training Section, in addition to required monthly in-service training, conducts basic canine instructor and handler schools for four disciplines. Basic canine school consists of 13-weeks - 520 hours of instruction and practical exercises.

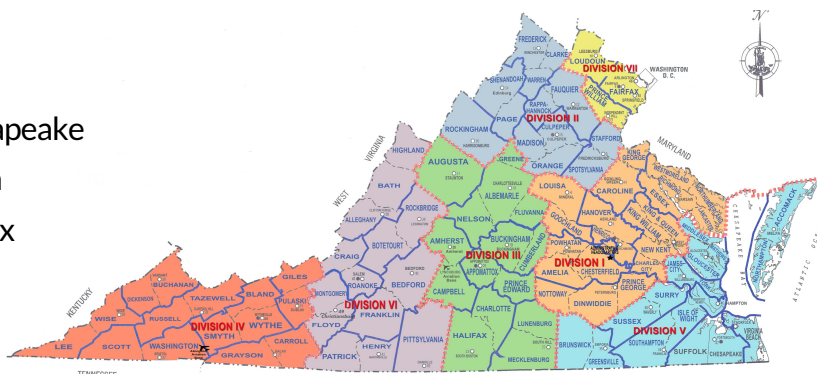


# BUREAU OF FIELD OPERATIONS (BFO)

BFO provides a full range of law enforcement services (criminal investigations and traffic enforcement) with an emphasis on highway safety. Uniformed BFO personnel patrol more than 74,000 miles of interstate and public highways throughout the commonwealth. The Bureau is divided into seven field division, and subdivided into 49 area offices. In addition, BFO includes the Aviation Unit and the Safety Division, which is comprised of the Motor Carrier Safety and Hazardous Materials Transportation Unit and the Motor Vehicle Safety Inspection Program. BFO also provides numerous specialty services which include Tactical Teams, Search and Recovery Teams, Crash Reconstruction Teams, Canine Teams, and the Motorcycle Unit.

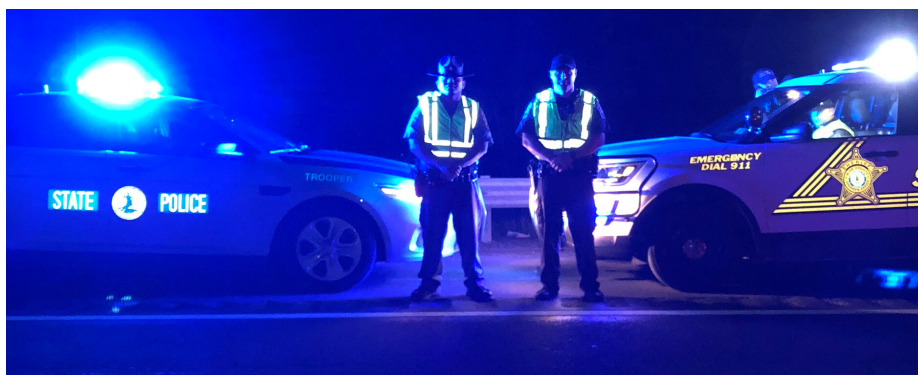

**Crime Prevention Program:** Assists state and local law government, private entities, civic groups, schools and the citizens of Virginia with proactively reducing the incidence of crime within local communities, neighborhoods and businesses. In 2018, VSP Certified Crime Prevention Specialists dedicated approximately 3,292 personnel hours to 3,121 presentations that reached nearly 81,000 Virginians. The presentation topics focused on personal, traffic and/or workplace safety. State police Crime Prevention Specialists also conducted 221 Community Policing Through Environmental Design (CPTED) Security Assessments statewide.



# BUREAU OF FIELD OPERATIONS (BFO)

## AVIATION UNIT

Provides aircraft support for search, rescue, law enforcement and medical evacuation missions through three Aviation Bases located in Chesterfield County, City of Lynchburg and the Town of Abingdon. Established January 1, 1984, the Unit today is equipped with one Bell 412 helicopters, four Bell 407 helicopters, two Airbus EC145 helicopters, and three Cessna fixed-wing aircraft. The Unit's Trooper-Pilots are qualified "Police Pilots," and have commercial pilots' licenses. The Unit employs three full-time mechanics for its fleet and exceeds minimum FAA maintenance requirements.

**Med-Flight/Medevac:** Operates from the Chesterfield and Abingdon Aviation Bases with operation costs shared with the Virginia Commonwealth University (VCU) Medical Center, Chesterfield County Fire and EMS, and Ballad Health Systems. In 2018, the two Med-Flight programs transported a total 763 patients.

# BUREAU OF FIELD OPERATIONS (BFO)

## SAFETY DIVISION

Enhances highway safety through the administration of the Motor Carrier Safety and Hazardous Materials Transportation Unit and Virginia Motor Vehicle Safety Inspection Program. The Division is subdivided into seven operational areas that correspond with each of the seven BFO Field Divisions. The Division also maintains and promotes intradepartmental safety, and maintains complete records on all motor vehicle or other accidents in which Departmental equipment is involved or personal injury to employees of the Department is experienced.

**Motor Carrier Safety Program:** Ensures commercial trucks and buses, operating on Virginia highways, meet all safety requirements through comprehensive inspections and measurement.

# BUREAU OF CRIMINAL INVESTIGATION (BCI)

Provides thorough and comprehensive investigations of all criminal matters mandated by Virginia statute and intelligence support relative to criminal activity in the Commonwealth.

The statutory mandates include the investigation of

- Any matter referred by the Governor;
- Requests by the Attorney General, commonwealth's attorneys, chiefs of police, sheriffs and grand juries of matters that constitute Class 1, 2, or 3 felonies;
- Elected officials when directed by the Governor, Attorney General or grand juries.



BCI is divided into seven geographic Field Offices that correspond with the BFO Field Divisions. Each of the field offices is then subdivided into a General Investigation Section (GIS) and a Drug Enforcement Section (DES).

# BUREAU OF CRIMINAL INVESTIGATION (BCI)

## BCI FIELD OFFICE - DRUG ENFORCEMENT SECTION (DES)

Provides full-time attention to the enforcement of drug laws in Virginia, and is committed to supporting local law enforcement agencies in their efforts. DES has in excess of 100 special agents across the Commonwealth responsible for performing operational narcotics enforcement investigations, including special undercover, wire intercept and marijuana eradication efforts. DES actively participates or is directly responsible for 53 multi-jurisdictional drug and gang task forces representing 120 jurisdictions in Virginia. DES also routinely assists with federal and local narcotics investigations.

# BUREAU OF CRIMINAL INVESTIGATION (BCI)

## CRIMINAL INTELLIGENCE DIVISION (CID)

Provides analytical and research support to local, state, and federal law enforcement agencies on matters pertaining to the Commonwealth of Virginia through the identification, documentation and dissemination of criminal intelligence concerning persons involved in organized crime, terrorist groups and those crimes involving multi-jurisdictional or serial crimes.

**Field Intelligence Unit:** Operates to improve intelligence collection and dissemination, to gather tactical intelligence in support of criminal investigations, and to use intelligence in support of strategic planning through strong liaison and interaction with department personnel and local law enforcement counterparts.

**Joint Terrorism Task Force (JTTF):** Coordinated through the FBI, VSP CID personnel are assigned to the the JTTF Task Forces in Virginia for the purpose of pursuing criminal leads, gathering evidence, making arrests, providing security for special events, collect and share intelligence, and respond to threats and incidents.

**Virginia Fusion Center (VFC):** Formed in 2005, the VFC is a joint operation between VSP and the Virginia Department of Emergency Management (VDEM) to focus on counter-terrorism intelligence investigations and analysis. VFC is occupied by local, state, and federal law enforcement agencies, public safety, emergency management, and/or the military in prevention of, or in response to, an incident. It maintains liaison with representatives from partnering agencies in order to facilitate and ensure communication between the Virginia State Police and those agencies, allowing for a more coordinated, informed response.



**Fusion Liaison Training Program:** Continues to grow and succeed in information to both the public and private sectors in order to enhance the safety of Virginia citizens. Topics include personal safety in places of worship, civilian response to an active shooter and suspicious activity recognition and reporting.

## HIGH-TECH CRIMES DIVISION (HCTD)

Conducts cyber-crime investigations and child exploitation/pornography investigations, as well as supports local, state, and federal law enforcement agencies through digital forensic analysis. HTCD special agents are assigned to each of the seven geographic BCI Field Offices.

**Northern Virginia - Washington D.C. Internet Crimes Against Children (ICAC) Task Force:** Counters society's rapid explosion of online child exploitation, pornography and predators through its 52 local, state and federal partnering agencies. Established in November 2004 through a grant from the U.S. Department of Justice, Office of Juvenile Justice and Delinquency Prevention (OJJDP), VSP serves as the coordinating agency. The grant provides for law enforcement training and equipment, and for conducting online investigations.

**Technical Support Section:** Supports significant investigations and uses sophisticated methods and technologies to assist any requesting law enforcement agency. The Hostage/Barricade Response Program was developed in 1997 to support federal, state and local law enforcement through the deployment of technical equipment and personnel resources.

## COUNTER-TERRORISM AND CRIMINAL INTERDICTION UNIT (CCI)

Established to suppress criminal activity with specific emphasis on reducing the flow of illegal narcotics on Virginia highways, public transportation systems, schools and parcel distribution businesses. CCI also partners with the multi-agency, multi-state High Intensity Drug Trafficking Areas (HIDTA) established throughout the Commonwealth in relation to analytical data concerning opioid overdose incidents, drug identity, reported drug packaging trends, and drug threat reports. CCI personnel are equipped and specially-trained to provide seven regional response teams to address chemical, nuclear and bio-terrorism events.

## HELP ELIMINATE AUTO THEFT (H.E.A.T.) PROGRAM

HEAT was established by the Virginia General Assembly in 1992. The program educates citizens about theft of vehicles and their parts, a crime that costs Virginians millions of dollars each year. HEAT also trains and supports local law enforcement officers in efforts to prevent auto theft. The HEAT program is a cooperative effort of VSP, Virginia Department of Motor Vehicles (DMV) and local law enforcement agencies throughout the Commonwealth.

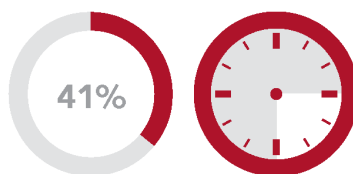

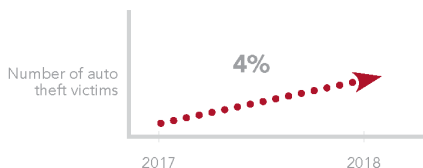

The number of arrests increased 3 percent in 2018. Nineteen percent of all arrests in 2018 were minors under the age of 18.



41 percent of all auto thefts occurred between **6 p.m. and 3 a.m.**



There were 9,657 reported victims of auto theft in 2018, an **increase of 4 percent from the previous year**.



More than **61 percent** of auto thefts occurred at a residence or parking lot/garage in 2018.



In 2018, the value of stolen motor vehicles totaled **\$94 million**, a **9.3 percent increase** from 2017, when the value of vehicles stolen was **\$86 million**.

HEAT hit the big screen over the 2018 holiday season, launching an ad campaign in movie theaters. Aimed at combating auto theft, the highly successful PSA ran between November 23 and December 27. Results were measured by a marked increase in the Program's social media traffic, as well as a 61% increase in traffic to the website.

**VIN Etchings:** As part of its preventive efforts to reduce auto thefts, the HEAT Program hosted 23 Vehicle Identification Number (VIN) Etchings in partnership with local law enforcement and at community events across the state. A total of 256 vehicles were etched.

## INSURANCE FRAUD PROGRAM (IFP)

Established in 1999, the IFP works to Stamp Out Fraud by providing training to law enforcement and teaching citizens how to identify and report insurance fraud. Insurance fraud is any act committed with the intent to obtain benefits or advantages where they are not entitled, usually through a sum of money. Insurance fraud costs American consumers more than \$80 billion dollars each year. Three common categories of insurance fraud are property fraud, casualty fraud and workers' compensation fraud.

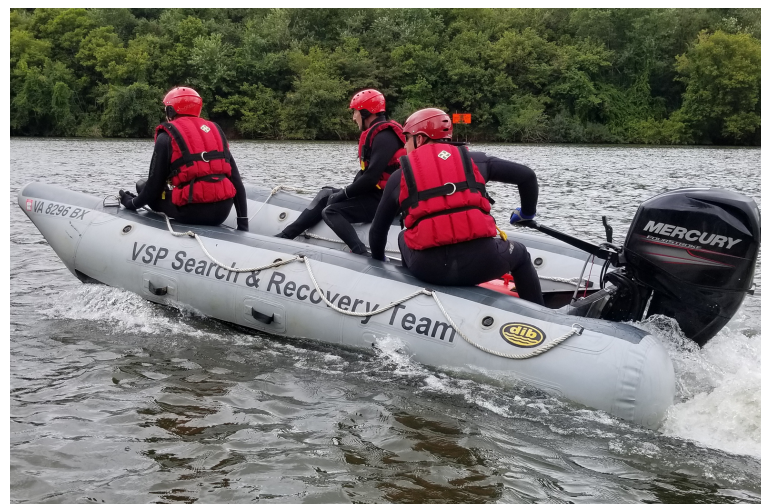
