Based upon the above criteria the only facility in the Williamsburg area for the Winter Conference has been the Clarion. This establishment has made improvements in some areas each year while falling short with other services. Therefore, at present the Board has decided, based on comments from the attendees at the December 2018 conference, not to return to this location. Efforts are being made to locate another facility in the general area, however, at this time no potential establishment has been identified. Finding a facility may require moving away from Williamsburg. Anyone having suggestions on a meeting location should contact Dave Copley or other Board members with their recommendations.
