## Insurance Information

During a very sad and trying time, the following information is provided by the Virginia State Police Alumni, Inc. to the families of deceased members to hopefully assist with the necessary completion of paperwork. Should you have any questions or are in need of further assistance, please contact Robert McCulloch, President at 804-739-0484, or one of the other officers of the Alumni.

For Department member spouses: If you need to know if you will continue to receive a portion of your spouse's retirement, you will need to call the Virginia Retirement System. You will also need to advise them if you wish to continue the insurance. If your spouse took 100% of their retirement, you will need to obtain insurance.

You will also need to obtain several copies of the Death Certificate, as most agencies will need certified copies to process any claims.

Family members may be eligible for Social Security survivor's benefits when a person getting benefits dies. You should make this call ASAP, as any checks received after the date of death, will most likely need to be returned or repaid. The same is true of the Retirement System payments.
