<u>Instructions for Completion of Criminal History Background Search forms</u>

*An example of a printed SP-167 form is at the end of these instructions

Effective November 1, 2010, the public is hereby placed upon notice that returned checks or dishonored money orders and/or credit card payment denials will incur a handling fee of \$50 in addition to the amount of the original payment. Requesting goods or services will be deemed to be acceptance of these terms.

On the left hand side of the screen, click on Criminal Record Check

Next look for Criminal History Records Check (SP-167) and click on the link "Click here to create your SP-167 request to be printed for mailing to the Virginia State Police"

- Once you have clicked on the link please follow the instructions on the screen;
 - o where you see "Form" please chose the correct form
 - SP-167 for individuals, agencies that are not authorized to use the SP-230, and out-ofstate requests
 - Individuals requesting and receiving their OWN Results have the option for <u>Remote Online Electronic notarization through</u> <u>NotaryCam</u> for an additional \$15.00 fee. (this does not include a fingerprint search)
 - SP-230 for Virginia agencies that are licensed through the Department of Health/Social Services/Medical (you cannot use the SP-230 to search your own record; the SP-167 must be used)
 - SP-266 for Sex Offender and Crimes Against Minors Registry search
- Cost Structure and Types of Records Searches Available:
 - Criminal History Record [SP-167 & SP-230]
 - \$15.00 per search
 - o Combination Criminal History/Sex Offender Registry [SP-167 & SP-230]
 - \$20.00 per search
 - o Sex Offender Search [SP-266]
 - \$15.00 per search
 - Non-Profit Organization Combination Criminal History/Sex Offender Registry
 - \$16.00 per search. The form must have attached documentation explaining the purpose of the search is for volunteering services for a non-profit organization. The documentation must include the name of the organization, address and the tax-exempt identification number of the organization
 - Non-Profit Organization Complete Sex Offender
 - \$8.00 per search. The form must have attached documentation explaining the purpose of the search is for volunteering services for a non-profit organization. The documentation must include the name of the organization, address and the tax-exempt identification number of the organization
- After typing in the correct information, click on Confirm.
- After you confirm all information is correct, click on <u>Generate</u>.
- This will generate the form. A PDF icon will appear on your screen to open and <u>print</u>.

- Signatures:
 - SP-167 this form requires notarized signatures.
 - Section 1: requires the notarized signature of the individual being searched
 - If you are requesting a search on yourself and the results are being mailed back to yourself, only Section 1 requires your notarized signature.
 - Section 2: requires the notarized signature of the individual who is receiving the results (Individual named in the 'Mail Results To' section
 - SP-230 this form requires the signature of the individual who is receiving the results (Individual named in the 'Mail Results To' section)
 - o SP-266 no signature required
- * The SP-167 form runs a search for Virginia convictions only; if you need a search on Virginia charges, dismissals and pending charges as well, please attach a completed fingerprint card to the SP-167 form.

Do not write anything at the bottom section of the form, Virginia State Police will mark the results accordingly in the bottom section.

The process can take up to 15 business days from the date we receive it.

- Payment:
 - o Business Check, Certified Check or Money Order
 - Make Payable to Virginia State Police; ensure check is dated and signed
 - NO personal checks are accepted
 - o Credit Card
 - Mark which credit card type will be used
 - Only MasterCard and Visa are accepted
 - Clearly write the credit card number in the designated section
 - Clearly write the credit card expiration date in the designated section
 - The card holder must sign in the designated section
 - o Virginia State Police Charge Account Number:
 - This is for NCJI account holders only
 - Cleary write in your NCJI Account# (A**** / B****)

Tips on expediting –

- -Pay by Business Check, Money Order or Certified Check
- -Mail in to us via next day air (at your cost)

When the completed form is returned, it will be marked accordingly at the bottom. An explanation of the results are:

- 'No Conviction Data Does Not Preclude the Existence of an Arrest Record' means that there were no Virginia convictions found.
- 'No Criminal Record Name Search Only' means that this search was ran as a specific type of 'purpose' (e.g. VISA-International Travel) it means there were no Virginia convictions or charges found.
- 'No Criminal Record Fingerprint Search' is if a fingerprint card was submitted along with the SP167 it means there were no Virginia convictions or charges found.
- 'No Sex Offender Registration Record' means that no Virginia Sex Offender Registration was found.
- 'Criminal Record Attached' means that a Virginia criminal record was found and is attached to the form.
