### AFIS Cloud Project

The Virginia State Police has been working with our Automated Fingerprint Identification System (AFIS) vendor, NEC Corporation of America, Inc., to replace the current AFIS system. The Virginia State Police is excited to announce that the contract was successfully executed on May 6, 2022. The new AFIS Cloud Solution, the Multi-modal Biometric Identification System (MBIS), will be operational in the second quarter of 2023. AFIS is a mission critical system, comprising numerous software and hardware components, and includes a security infrastructure that complies with FBI and VSP requirements.

Over the past thirty years, the AFIS system has been highly customized to meet VSP's requirements. However, the outdated hardware and software complicates VSP's need to stay compliant with FBI mandates. Given the complexity of AFIS and the need to be operational 24 hours a day, 7 days a week, it is difficult and costly to upgrade AFIS hardware and software on VSP's traditional on-site computing architecture. Hence, the goal of the AFIS Cloud Project is to remove on-site server dependencies by migrating to a hosted solution on the Microsoft Azure



Government Cloud. Moving to the Cloud environment has many advantages for VSP and agencies connecting remotely. Moving forward. agencies can expect quicker responses as MBIS will have increased matching power. Also, access to automatic updates will reduce downtimes the experienced in the past.

The AFIS Cloud Project aims to expand the overall functionality and dependability of current

hardware and software. The project will improve functionality such as fingerprint matching capabilities and meet several key objectives including reducing server failures and providing continuous application updates. The project aims to expand hardware components to adhere to FBI security compliance and will address VSP's disaster recovery requirements.

### Web Browser Updates



Effective **June 15, 2022** the Internet Explorer (IE) 11 desktop application will no longer be a supported internet browser and should no longer be used to launch the OpenFox Messenger application. Please begin using an alternative supported browser, such as Microsoft Edge Chromium, Google Chrome, or Mozilla/Firefox to launch the OpenFox Messenger application.

Note: To ensure that the Messenger application receives all necessary updates, it is strongly recommended that desktop shortcuts are not used.

Instead, it is recommended that you type the URL directly into the web browser or make the Messenger Launch page your default web page.



### **Community Policing Act Data Collection**

As of the date of this report, over 1.6 million stops have been collected. The analysis of the data collected will be conducted and reported by the Virginia Department of Criminal Justice Services.

Effective July 1, 2022, the residency of the person involved will be required to be collected. It is currently optional. Although not yet required, 80 agencies have begun collecting residency data for their stops. Based on the data provided by agencies already reporting residency, over 20 percent of people stopped have an out-of-state residence. One out of three people stopped are Virginia residents stopped outside of their home jurisdiction.

#### **Violent Crime Counts**


Murder	Rape (FBI Definition)	Aggravated Assault	Robbery
