## CJIS Division

## CCRE

### Dissemination Limitations: Misdemeanor Possession of Marijuana

On November 20, 2020, the Virginia State Police, Central Criminal Records Exchange (CCRE) began to restrict the dissemination of §18.2-250.1 possession of marijuana information that was reported to the CCRE with an offense date prior to July 1, 2020. Virginia law enforcement agencies will still have access to prior possession of marijuana arrest and disposition information for criminal justice purposes, however, the information will not be accessible for certain non-criminal justice employment background checks or law enforcement agencies outside of the Commonwealth of Virginia. Dissemination limitations related to §18.2-250.1 possession of marijuana can be found under §19.2-389.3 Marijuana possession; limits on dissemination of criminal history record information; prohibited practices by employers, educational institutions, and state and local governments; penalty.

### Criminal History: Restoration of Firearm Rights

Beginning January 1, 2021 restoration of firearms rights will be reported on the criminal history (rap sheet) as required under § 18.2-308.2 (C) Code of Virginia. Under this provision the Clerk of the Circuit Court will forward to the Central Criminal Records Exchange (CCRE) a copy of the firearm restoration order, a complete set of the petitioner's fingerprints and the Notice of Restoration of Firearm Rights form. This information will be used to identify and record the restoration of firearms rights on the petitioner's criminal history record. As provided in the example below, the restoration of firearm rights notification will be located in the top portion of the criminal history along with a caveat related to the restoration in the lower portion of the record:




## Record Numbers Continue

The FTC has seen an increase of 47.9% this year without accounting for December transactions. Projections estimate a total between 725,000 to 750,000 transactions for the 2020 calendar year. Last year's transactions topped out at 484,550.

### Updated Registration Statuses

July 1, 2020 brought many changes to the SOR Section, the biggest two being the change of classification and the verification of registration information intervals. Virginia has moved to a three tier classification from the two classifications initially implemented in 1997. Tier III replaced Sexually Violent, Tier II and Tier I replaced Sexual.

The verification of registration information interval was based on the initial registration date and will now be based on birth month and last name. Additionally, only those classified as Tier III or murder will be required to reregister. Those classified as Tier II and I will be verified in person by SOIU. In response to COVID-19, SOR created five forms to be used to update employment, school, address, vehicle changes, and re-register while maintaining social



### Annual User Validation

As we all anxiously await the start of the New Year, it's a good time to review your current operations and think ahead on ways to improve productivity. A new year has a way of getting you inspired to get organized and remove the clutter. So as you prepare to conduct the yearly reconciliation and updating of your agency's files, another area to keep in mind is your certified NCIC/VCIN users list. FBI CJIS policy requires all agencies to conduct a yearly validation of their users to ensure it includes current, certified users with the appropriate security level to perform their assigned job duties. This includes notifying the VCIN office when an employee leaves or transfers to another department.

# UCR

## A New Data Collection



Like the other CJIS Sections, Uniform Crime Reporting (UCR) is no stranger to change during this year. Several legislative and organizational changes have transformed UCR into a data hub for the Virginia Department of State Police. As of July 2020 the Community Policing Act introduced the creation of a data collection; recording all motor vehicle stops and subsequent demographic information. After the data is collected, it will be sent to the Department of Criminal Justice Services for further analysis, reporting, and publication.

## Restructuring and Reorganization

In addition to new data collections, UCR has also gained new responsibilities as we support our sworn members. The record management (LEAMS) and evidence management systems (TraQ) for the Department will now be housed under the UCR Section.



The addition of these management systems is a natural fit as they specifically link to the current crime data collections maintained in UCR. So far this has proven to be beneficial for our sworn users, who now have a team of personnel to assist them. The team continues to advance the UCR Section's mission to provide the most accurate data in regards to crime in the Commonwealth.
