CCRE

Model Policy Published

In August 2019 the Virginia State Police published its model policy on the collection of fingerprints and reporting of criminal history information. A key element within the model policy is under the section that illustrates reportable criminal history information to the Central Criminal Records Exchange (CCRE). This section outlines reportable adult offenses under §19.2-390 Code of Virginia and juvenile offenses under §16.1-299 Code of Virginia. In addition to outlining reportable adult and juvenile offenses to the CCRE, the policy also provides best practices to be followed when procuring fingerprint information.



All the information provided in the model policy document is aimed at supporting the documentation and reporting of criminal history information. Without booking fingerprints, an offender's arrest and case disposition will not appear on his rap sheet. As a result, that offender could be improperly approved for a firearms purchase, be employed in a position of trust, or be given a lighter sentence on a future charge. Updates for VCIN Training – nexTEST

January 13, 2020 marked the first official update for the online training for VCIN, nexTEST. This application was launched back in the spring of 2018 with much success. The update came with huge improvements regarding testing, which will put a lot of new and current users' minds at ease.

From the initial startup, nexTEST had a test behind every module you reviewed. The current update has reduced that testing, based on your VCIN access – Limited (formerly Level B) or Full (formerly Level A) Access.

UCR-IBR

Updates in UCR-IBR (Uniform Crime Reporting-Incident Based Reporting)

VSP serves as the repository for law enforcement agencies in the Commonwealth to report their crime data in compliance with the FBI's National Incident Based Reporting (NIBRS) Program. VSP's IBR section has implemented a new data repository system. The new IBR website includes a public portal which allows anyone to retrieve crime data from the previous calendar year. This will prove beneficial not only to law enforcement, but to public, judicial, legislative, and academia persons who use Virginia crime data.

Use-Of-Force Data Collection

The FBI began a voluntary Use-Of-Force Data Collection of which Virginia has opted to participate. The updated collection gathers additional data fields to provide a detailed view of the use of force by law enforcement officers in Virginia. Data is collected in the following situations: incidents where any use of force results in the death or serious bodily injury of a person, as well as when a law enforcement officer discharges a firearm at or in the direction of a person.

New Crime Codes

As of 2016, the FBI identified new crime codes for collection. As of March 2019 Virginia began collection of this information as well. The addition of these codes will provide more information as to the crimes occurring in the Commonwealth.

- Animal Cruelty
- Human Trafficking, Commercial Sex Acts
- Human Trafficking, Involuntary Servitude
- Identity Theft
- Hacking/Computer Invasion
- Purchasing Prostitution
