#### **LEAN MANAGEMENT TRAINING**

CJIS is currently conducting the 4th LEAN Six Sigma Yellow Belt training. The class consists of members from Human Resources (HR), Data Analysis & Reporting Team (DART), and the Bureau of Administrative Support Services (BASS). The Core principle of the LEAN SIX Sigma Program is to promote efficiency of processes and customer service through the effective change management.



The students attend a scheduled class every other Thursday. During class, students receive instructions and coaching through all steps of the change management process. Students who successfully complete the course and all objectives will receive a SIX Sigma Yellow Belt Certification.

### INTERPRETING THE RESTORATION OF FIREARMS RIGHTS ON A CRIMINAL HISTORY

Individuals convicted of a felony offense in Virginia can apply to the Governor of Virginia, through the Secretary of the Commonwealth's Office, to have their civil rights restored (the right to vote, serve on a jury, be a notary, or run for public office). Once the Governor has granted the request, the individual is then eligible to petition a Virginia Circuit Court for the restoration of their right to purchase or possess a firearm. The Code of Virginia requires the petitioner to have a valid restoration of civil rights granted prior to restoration of their firearms rights under § 18.2-308.2(C).

A civil restoration, or simple pardon, applied to the criminal history record is visible below each specific offense and disposition that it applies to. A firearms restoration only appears as a caveat at the very bottom of the criminal history record and is date specific. An individual can be convicted of an additional felony offense after the restoration of civil or firearms rights has been granted. This would effectively make the individual ineligible to purchase or possess a firearm again. Therefore, it is essential to review the date of the last felony conviction on the record against any restorations also notated on the criminal history record when making an arrest or enforcement decision based on the content of the record.

Restorations of Firearms Rights have only been notated on the Criminal History Record since January 2021. The absence of a notation does not indicate the individual does not have a valid restoration of rights. The validity of a restoration of firearms rights can be confirmed with the issuing Virginia Circuit Court. Restorations of rights due to a felony conviction in another state are processed according to that state's procedures.




#### **DART**

#### **COMMUNITY POLICING ACT**

The DART Section is working on utilizing the functionality of the existing crime and use of force data repository to provide the same repository services for Community Policing Act (CPA) stop data.

Currently, the entire process of collection and review of CPA stop data is manual. With the creation of the CPA repository, the process of receipt and subsequent quality control review of data collected from local law enforcement agencies will become automated. Between July 2020 and December 2022, law enforcement agencies in Virginia reported making approximately 2.4 million stops.



Additionally, in anticipation of the transition to an online repository, as of July 1, 2023 agencies are required to report data monthly instead of quarterly. This will ensure that we receive data in a timely manner for publication to the Open Data Portal and DCJS.


#### **CRIME IN VIRGINIA**

#### **BIPARTISAN SAFER COMMUNITIES ACT (BSCA)**

Starting January 1, 2023, the Virginia State Police Firearms Transaction Center started conducting additional outreach for NICS background checks, in accordance with the Bipartisan Safer Communities Act of 2022.

When individuals under 21 attempt the transfer of a firearm through a Federal Firearms Licensee, the Virginia State Police Firearms Transaction Center is required to contact the law enforcement agency, of the purchaser's resident jurisdiction. VSP is primarily reaching out to see if the resident jurisdiction has any relevant information that would impact the subject's eligibility to receive a firearm. This information includes but is not limited to: (i) Mental health admissions subject to a Temporary Detention Order, (ii) Protective Order information where the purchaser is a respondent, (iii) pending court case information, (iv) interactions with the individual where drugs were involved, and/or (v) any criminal charges relevant to the disqualification for firearms purchases.



The lawful eligibility of a firearms purchase must be completed within 3 business days of the subject attempting to purchase a firearm. If any law enforcement agency has information that may prohibit the subject from the purchase of a firearm, there is an extension in the BSCA legislation that allows for an additional 7 days to complete that research.

Since January 1, 2023, we have already processed over 3,104 requests for purchasers under the age of 21.
