B. Vote on Membership Proposal

Ron Kranchick said a committee had been formed and had prepared the language in Article IV, Section 2. (D), Admission to Membership, to allow an appeal process if an applicant is turned down by the Board. John O'Neil said he, Andy Engemann and Phyllis Allgood had prepared the language because of hearing that the Alumni is just a "good ole boys' group;" the Alumni is a social group to enjoy each other's company. There are two criteria to prevent membership approval (1) convicted of any criminal offense classified as a felony, and (2) Must be of such character as to uphold integrity of Department of State Police and Alumni. If a person is turned down and may wonder if they can do anything, an appeal process would be available to them, if the new language is approved by the general membership today. He then read Article IV, Section 2. (D), (a copy was provided to each member in the Grapevine and also to each member attending the meeting.) He said the suggestion coming from this committee was presented to the Board and the Board felt it should come before the general membership for approval. He said 2/3 of the general membership attending the meeting must approve to become part of the new by-laws. Each person voting (only Alumni members) will be done by secret ballot.

Ron Kranchick said the proposed appeal process, Article 4, Section 2. (D) passed with 71% in favor.

C. George Galo, Membership Directory Coordinator – He said he has been the Directory Coordinator for 13 years and is looking for someone to take over and willing to work with them until they learned the process. He said he spends approximately three to four days a month on keeping the directory up-to-date and could share the duties while learning the position. He felt a younger, energetic alumni member who likes working on the computer would be a good fit, it is not complicated, just time consuming and if anyone would like to call him and talk about it, feel free. He stressed the importance of the directory with names, addresses, phone numbers, etc.

Ron Kranchick then thanked George for all of his hard work on keeping the directory up-to-date.

There being no further business, a **MOTION** to adjourn was made by John O'Neil, seconded by Art King and the motion was unanimously approved. The meeting was adjourned at 3:55 p.m.
